

**Resolution To Initiate The Process To Censure the Speaker of the Texas House-
Dennis Bonnen (R-Angleton)**

WHEREAS, Speaker of the Texas House Dennis Bonnen (R- Angleton) violated RPT Principles #2 and #8 by appointing an anti-gun Democrat Representative- Poncho Nevárez (D-Eagle Pass)- to chair the Homeland Security & Public Safety Committee and a pro-abortion Democrat Representative- Senfronia Thompson (D-Houston-) to chair the Public Health Committee, thus ensuring multiple pro-gun and pro-life bills would either never receive a hearing or never be put to a vote in those committees, and

WHEREAS, Speaker of the Texas House Dennis Bonnen (R- Angleton) violated RPT Principle #5 by giving a demonstrably false account of Constitutional Carry activist Chris McNutt's actions while blockwalking in the Speaker's neighborhood, thus causing undue harm to a private citizen, and

WHEREAS, Speaker of the Texas House Dennis Bonnen (R- Angleton) violated RPT Principle #4 by ignoring a valid point of order, which was called when SB 10- the mental health bill- was added as an amendment to SB 11- the school safety bill, thus ensuring an unprecedented expanse of government power, and

WHEREAS, Speaker of the Texas House Dennis Bonnen (R- Angleton) violated RPT Principle #3 by threatening to penalize House members if they attacked incumbent members of either Party during the Primary or General elections, thus potentially limiting all Texans' representation in the House, and

WHEREAS, Speaker of the Texas House Dennis Bonnen (R- Angleton) violated RPT Principle #5 by making offensive statements regarding other members of the House, thus bringing embarrassment to his office and the Party,

RESOLVED, the Executive Committee of the LAVACA COUNTY REPUBLICAN PARTY COUNTY EXECUTIVE COMMITTEE hereby respectfully calls on the Executive Committees of the Republican Parties of Brazoria and Matagorda Counties to initiate the process to censure the Speaker of the Texas House- Dennis Bonnen (R-Angleton)- for the above actions to the full extent allowed by the Republican Party of Texas under Rule 44.
